### **Seminar on Health & Safety**

The Occupational Health & Safety Authority (OHSA) would like to draw the attention of the general public that a feature appearing in a local English language newspaper on Sunday November 4, 2007, referring to a seminar to be held by the Authority in partnership with a local non-governmental organisation and a commercial entity, is incorrect and misleading.

This is not the first instance whereby the OHSA had to resort to declarations to correct misguided impressions on training services and employers' obligations in this regard. Whilst reaffirming its autonomy and without prejudice to further action, the Authority would like to point out that it is not linked to any commercial centre or other organisation providing occupational health and safety services. The OHSA would like to advise the public that as part of its ongoing efforts to promote awareness and high standards of workplace health and safety, it regularly organises training courses and seminars addressed to stakeholders. ihaddem. Filwaqt li tirriaferma l-awtonomija taghha, u minghajr pregudizzju ghal xi passi li tista' tiehu, l-Awtorita tiddikjara li m'ghandha ebda konnessjoni ma xi entita' kummercjali jew entita ohra li toffri servizzi ta' sahha u sigurta. L-Awtorita tfakkar lill-pubbliku li bhala parti mill-impenn taghha li xxerred l-gharfien u tgholli l-livelli ta' harsien u prevenzjoni ta' sahha u sigurta' fuq il-lant tax-xoghol, hija toffri tahrig generali u *seminars* immirati lejn kull min ghandu nteress f'dan il-qasam.
